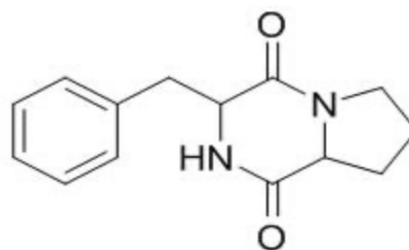

Cyclo(Phe-Pro) can inhibit cancer cell growth and induce apoptosis in HT-29 colon. [1]
Cyclo(L-Phe-L-Pro) is a signal molecule controlling the expression of genes important for the pathogenicity of *Vibrio* spp. [2]
Cyclo(Phe-Pro) produced by *V. vulnificus* actively suppresses the innate immune responses of the host, thereby facilitating its survival and propagation in the host environment [3]
Cyclo(Phe-Pro) shows weak cytotoxicity in vitro against HCT-8, Bel-7402, BGC-823 [4]
Cyclo(Phe-Pro) shows broad spectrum antibacterial properties. [5]

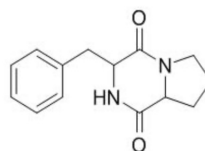
