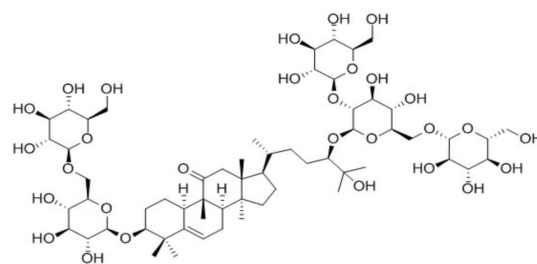

BIOLOGICAL ACTIVITY OR INHIBITORS

11-Oxo-mogroside V and mogroside V, two natural sweeteners isolated from the fruits of *Momordica grosvenori*, exhibit strong inhibitory effect on the primary screening test indicated by the induction of Epstein-Barr virus early antigen (EBV-EA) by a tumor promoter, 12-O-tetradecanoylphorbol-13-acetate (TPA); they exhibit the significant inhibitory effects on the two-stage carcinogenesis test of mouse skin tumors induced by peroxyxynitrite (ONOO) as an initiator and TPA as a promoter; 11-oxo-mogroside V also exhibits the remarkable inhibitory effect on two-stage carcinogenesis test of mouse skin tumor induced by 7,12-dimethylbenz[a]anthracene (DMBA) as an initiator and TPA as a promoter [1] 11-Oxo-mogroside V, a sweet element of *Siraitia grosvenori* (SG) extract, provides the anti-oxidative property of SG which might reduce the atherogenic potential of low-density lipoprotein (LDL). 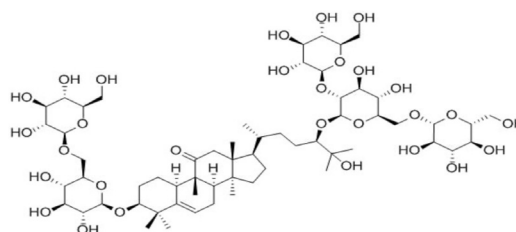
