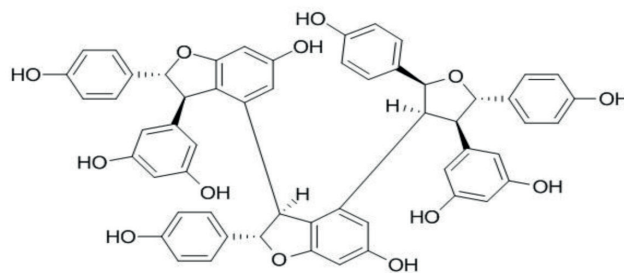

BIOLOGICAL ACTIVITY OR INHIBITORS

Kobophenol A has protective potential against the toxic effects of sodium nitroprusside (SNP), it can inhibit SNP-induced cardiac H9c2 cell death through suppressing activation of JNK and preserving mitochondrial anti-apoptotic Bcl-2 and Mcl-1.[1]

Kobophenol A has proliferative effects and enhances alkaline phosphatase (ALP) activity in osteoblast cells and these findings provide insights into the development of a therapeutic approach of kobophenol A in the prevention of osteoporosis and other bone disorders.[2]

Kobophenol A inhibits cetylcholinesterase (AChE) activity in a dose-dependent manner, and the IC50 value is 115.8 microM.[3]

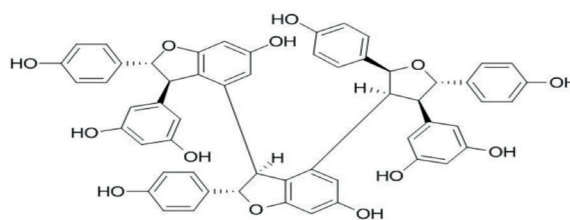
